Whereas, in pursuance to this office advertisement notice No. DIP/J-3534 dated 10-08-2016 and as recommended by the selection committee constituted in terms of SRO-384 of 2009 dated 14-12-2009 Sh. Jeevan Bandhu was appointed as Carpenter Vide order No. 236/AHJ of 2016 Dated. 26.08.2016;

Whereas Sh. Jeevan Bandhu has resigned from this office through proper channel hence, causing a vacancy;

Sh.Dheeraj Kumar S/O Sh. Tarseem Lal R/O Badyala Chak, Tehsil Akhnour Distt Jammu the next eligible candidate as per the merit list is hereby appointed in place of Sh. Jeevan Bandhu as Carpenter under SRO 384 of 2009 dated. 14.12.2009 read with 409 of 2013 in the pay scale of 5200-20200+2400 for a period of 1 year extendable up to maximum of six years (one year at a time and subject to the good performance and conduct) or till selection/promotion is made in accordance with the rules of recruitment governing these posts whichever is earlier.

The appointment in terms of SRO-384/409 shall subject to the following condition.

- a) The appointment under these rules shall not entitle the appointee to any preferential claim for regular appointment under normal process of selection / appointment.
- b) The appointment on academic arrangement under SRO-384 of -2009 read with SRO- 409 shall terminate on the attainment of 65 years of age by the appointment.
- c) The service of the appointee shall be terminable before the expiry of the tenure of appointment with one month's notice from either side or payment of one month's salary in lieu of notice by appointing authority.
- d) The appointee shall have to execute an arrangement with the Government on the prescribed form appended as Form 'A' to SRO -384 OF 2009
- e) The appointee shall be paid monthly salary as per the scale provided in the SRO-384 i.e. pay equal to the revised basic pay which corresponds to the minimum of the pre-revised scale for the post as per SRO- 93 dated 15-4 -2009 and Dearness Allowance.
- f) The appointee shall not be entitled to any other additional monetary benefit what so ever except of house rent allowance as applicable to in service candidates carrying minimum of the pre -revised scale of the post subject to fulfillment of the conditions provided under the relevant rules in this regard.

- g) In matters of discipline and conduct the appointee shall be governed by rules regulations and orders in vogue in the state Civil services on the subject.
- H) Any residuary matter shall be governed by the SRO-384 dated 14-12-2009.
- I) The appointee shall be allowed to join on production of certificate and testimonial in original.
- J) The appointee are directed to report to the Principal, Govt. Medical College, Jammu within 7 days of the issuance of this order failing which their selection shall be deemed to have been cancelled.
