The engagement of the candidates is subject to the following conditions:

- 1. The candidates shall report to the Principal, Government Medical College, Jammu for joining within a period of twenty-one (21) days, from the date of issuance of this order, failing which their engagement as such shall stand cancelled without any further notice.
- 2. The arrangements shall be purely on temporary basis and shall not confer upon the candidates any special claim/ right for their appointment against the said posts on regular basis as and when the same are filled under rules.
- 3. The candidates shall have to execute an agreement with the Government on the prescribed form in terms of S.O 364 of 2020 dated 27.11.2020. The engagement shall be for a period of one year or till the posts are filled-up on regular basis on the recommendations of Jammu and Kashmir, Public Service Commission, whichever is earlier.
- 4. The above engagements shall be regulated under other terms and conditions as specified in S.O-364 dated 27.11.2020. The engagements so made on academic arrangement basis shall be extendable upto maximum of six years (one year at a time and subject to good performance and conduct) or till selections/promotions are made in accordance with the rules of recruitment governing the posts, whichever is earlier and the extension so granted under these rules shall not be beyond a period of six years under any circumstances.





5. The salary in favour of the engaged doctors shall not be released unless a satisfactory report is received from the Criminal Investigation Department, J&K.
