The appointment of the aforementioned candidates shall be subject to the following conditions:

1. The appointees shall submit their joining reports to the Principal, Govt. Medical College, Jammu within a period of 21 days from the date of issuance of this order and in case of failure of any appointee to join within the stipulated period of time, his/her appointment shall be deemed to have been cancelled ab-initio, without any further notice.

2. The appointees shall be allowed to join only on the production of the following documents:

- a. Academic Qualifiaction Certificates.
- b. Matriculation/Date of Birth Certificate.
- c. Health Certificate issued by the Chief Medical Officer.
- d. Domicile Certificate issued by the Competent Authority.
- e. That if the candidate has taken loan for self-employement from DIC/Employment Department, to be ascertained from the District Industries Centre (DIC) and District Employment and Counselling Centre of the Domicile District, he/she shall relinquish the proprietorship of unit/enterprise and also stakes, if any, in such self-employment unit/enterprise before joining the Government Service. He/she shall be required to repay the entire loan liability in suitable EMIs to be worked out by the DDO concerned from his/her salary. DDO concerned shall obtain an affidavit from the concerned appointee regarding both relinquishment of proprietorship and stakes, if any. In such self-employement unit/enterprise and recovery to be made and also personally monitor it recovery.
- f. Relevant Category Certificate, wherever applicable.
 - g. Character Certificate issued by the concerned Police Station.
 - h. Any other document(s) as required under rules.
- 3. Verification/genuineness of the qualification certificates and the reserved category certificates from the concerned issuing authorities.
- 4. The salary of the appointee(s) shall not be drawn and disbursed to them unless, satisfactory report in respect of (3) above is received in his/her favour.
- 5. The appointment of the candidate(s) shall be governed under Jammu and Kashmir Special Recruitment Rules, 2020 notified vide S.O. 194 of 2020 dated 17-06-2020 and Jammu and Kashmir Probationer (Condition of Service, Pay and Allowances) and Fixation of Tenure Rules, 2020 notified vide S.O. 192 of 2020 dated 17-06-2020.
- 6. The appointee(s) shall be governed by the "New Pension Scheme" as notified vide SRO-400 of 2009 dated 24-12-2009.
- 7. The interim arrangement, if any, made against the above post shall be deemed to have been terminated forthwith.
- 8. The appointment in Divisional Cadre is non transferable from one Division to another or from one Medical College to another.
- 9. The appointment of the selected candidate(s) shall further be subject to outcome of the writ petition (s), if any, pending on the subject before any Court of Competent jurisdiction.
- 10. The inter-se-seniority of the appointees shall be as per the merit secured by them in the selection process, as indicated against each in the selection list furnished by the J&K Service Selection Board.



The appointee(s) shall give an undertaking duly attested by the First Class Magistrate in the shape of an affidavit to the effect that:

- the qualification from the concerned issuing authorities, verification certificate/reserved category (wherever applicable) is found forged, false or fake, the appointee shall have no claim for appointment.
- b) The appointee shall abide by all the terms & conditions as laid down in their appointment order.
- c) The appointee shall be liable for action as warranted under rules for violating any of the aforementioned conditions as indicated in their appointment order.
