Whereas applications were invited from eligible candidates for the post of EMG Technician on academic arrangement basis under SO-364 dated 27-11-2020 in Govt. Medical College and its Associated Hospitals, Jammu, UT of J&K vide advertisement notice no. 03/AHJ of 2023 dated 26-07-2023.

Whereas, criteria as mentioned in the Advertisement notice has been adopted for the preparation of the merit;

Now, in view of above and as recommended by the selection committee constituted in terms of SO-364 of 2020 dated 27-11-2020, the candidate as Annexure-A (list enclosed), is hereby selected as EMG Technician in the pay scale of 35400-112400 (Level-6) against the available posts lying vacant in various hospitals of GMC and its AHJ. The selection is strictly based on the merit, for a period of one year, extendable upto maximum of six years (one year at a time and subject to good work & conduct) or till the selection/promotion is made in accordance with the Rules of Recruitment governing these posts, whichever is earlier.

The selected candidate is directed to report to the Principal, Govt. Medical College, Jammu within a period of 10 days from the date of the issuance of this order.

**The selected candidates shall be allowed to join only on the production of the following certificate/testimonials in original:**

- Academic/Technical Qualification.
- Date of Birth Certificate.
- Health Certificate from the concerned Chief Medical Officer of the District.
- Domicile Certificate.
- Character Certificate duly issued by the concerned Police Station/SHO.
- Relevant Category Certificate (if any).

**The selection is strictly governed by the following terms and conditions of SO-364:**

- The selection under these rules shall not entitle the selected candidates to any preferential claim for regular appointment under normal process of selection/appointment.
- The selection on academic arrangement basis shall by itself stand terminated on the attainment of 65 years of age by the selected candidate.
- The services of these candidates shall be terminable before the expiry of the tenure of appointment with one month's notice from either side or payment of one month's salary in lieu of notice by appointing authority.
- The selected candidate shall have to execute an agreement with the Government on the prescribed form appended as Form "A" to SO 364 of 2020.



5. The selected candidates shall be paid consolidated pay equal to the revised basic pay which corresponds to the minimum of the pre-revised scale for the post as per SRO-193 dated 24-04-2018 and Dearness Allowance.
6. The selected candidate shall not be entitled to any other additional monetary benefit, what so ever except of House Rent Allowance as applicable to in-service candidate carrying minimum of the pre-revised scale of the post subject to fulfillment of the candidates provided under the relevant rules in this regard.
7. In matter of discipline and conduct, the selected candidate shall be governed by the rules, regulations and orders in vogue in the Civil Services Rules on the subject.
8. Any residuary matter shall be governed by the SO-364 dated 27-11-2020.
9. The salary of the selected candidate shall not be drawn and disbursed unless satisfactory report of his concerned documents/relevant documents is received in his favour.

**The selectee shall given an undertaking duly attested by the First Class Magistrate in the shape of an affidavit to the effect that:-**

- a) If on verification from the concerned issuing authorities, the qualification certificate/reserved category (Wherever applicable) is found forged, false or fake, the appointee shall have no claim for appointment.
- b) The selectee shall abide by all the terms and conditions as laid down in the appointment order.
- c) The selectee candidate shall have to execute an agreement stating that he/she will not take part in any kind of political activity and strikes




