A.	Pay scale and salary	<p>I). Consolidated pay equal to the revised basic pay, which corresponds to the minimum of the Pay Level 11 (67700-208700) for Assistant Professor & Pay Level 6F(40800-129200) for Tutor plus Dearness Allowance.</p> <p>(II) Selected candidates/appointees shall also be entitled to HRA as applicable to in-service candidates carrying the minimum of revised scale subject to the fulfillment of conditions provided under relevant rules in this regard.</p> <p>(III) Selected candidates/appointees shall not be entitled to any other monetary benefits, whatsoever.</p>

C.	Other Conditions of Service	<p>Engagement shall be terminable on either side by prior Service notice of one month or payment of one month's salary by the appointing authority in lieu of prior notice. Engagement shall be terminable without any further notice, whenever the posts are filled-up on regular basis under rules by the competent authority and the Selected candidates/appointees shall have no claim, whatsoever, against the Government or the Appointing Authority. In the matter of discipline and conduct, the Selected candidates/appointees shall be governed by the rules, regulations and orders in vogue in the Union Territory Service on the subject.</p>
D.	Agreement to be signed	<p>Selected candidates/appointees shall be allowed to join only after they sign agreements as per format prescribed as Form-A appended to S.O. 364 of 2020, dated: 27.11.2020.</p>
E.	Nature of engagement	<p>The engagement made herein shall and shall always be on Academic Arrangement Basis only without conferment of any preferential right on the Selected candidates/appointees for regular appointment against the posts</p>

3. The selected candidates/appointees shall report to the office of the undersigned within a period of Seven (7) days falling which they shall forego their selection, which shall be deemed to have been cancelled ab-Initio without any further notice.

4. They shall be allowed to join only on the production of the following documents/certificates in original:

- I. Date of Birth & Degree Certificate M.Sc Nursing.
- II. Certificates from the concerned District Industries Centre (DIC) and District Employment & Counseling Centre to the effect that no loan under any self employment scheme has been taken by the appointee.
- III. Domicile Certificate.
- IV. Health Certificate from the Standing Medical Board.
- V. Agreement as per format prescribed as Form-A appended to S.O. 364 of 2020, dated: 27.11.2020.
- VI. An undertaking in the shape of an affidavit duly attested by the 1st Class Judicial Magistrate to the effect:
 - a. That in case an adverse report about their Qualification, Date of Birth, Marks certificates and Domicile certificate etc, if any, is received from the competent authority to whom the references shall be made by the Controlling Officer, the candidates shall have no right to claim for their engagement. Their engagement as such shall be deemed to have been cancelled ab-intio. They will not also claim for any dues.
 - b. That they have fully understood the terms, conditions and nature of their engagement basis and will not claim for their regularization after completion of the term or at any point of time
- VII. Character and Antecedents verification from concerned Police station & CID which states that there is nothing adverse against above mentioned candidates

5. The engagement shall be governed by the other terms and conditions, as are not specifically mentioned herein this order but are made applicable in case of such engagements any time by the contracting authority.

6. The Services of the engaged person shall be terminated in case their performance is not satisfactory/up to the mark.

7. The concerned DDO shall keep the salary of the aforesaid contractual staff on hold till verification of all relevant documents.

8. One month's salary of the Incumbents shall not be paid till completion of the term of engagement as such in terms of existing S.O. 364 of 2020.
