SHOW CAUSE NOTICE

Whereas you were appointed as Lecturer in the Department of Dermatology in Govt. Medical College, Jammu on the recommendation of PSC vide letter No. PSC/Dr/Lect/Dermatology/2019 dated 11-02-2021 read with Administrative Department order No. 130-JK (HME) of 2021 dated 22-02-2021, Wherein it clearly mentioned that you shall be allowed to join only on production of the following documents certificate in original.

The appointee shall be allowed to join only production of the following documents/certificate in original:-

- 1) Date of Birth Certificate.
- 2) Qualification Certificate .
- 3) Certificate from the concerned District Industries Centre (DIC) and District Employment & Counseling Centre to the effect that no loan under any self employment scheme has been taken by the appointee.
- 4) Domicile Certificate.
- 5) Health Certificate from the Standing Medical Board.
- 6) Reserved Category Certificate.
- 7) Any other documents as required under Rules.

Further, you were directed to report to the office of the Principal, Government Medical College, Jammu for joining, with a condition that in case of failure of the appointee to join within a period of 21 (twenty one) days from the date of issuance of this appointment order, he shall forego his appointment, which shall be deemed to have been cancelled ab initio without any further notice.

Furthermore your appointment was made as per the following terms of conditions:-

1) The appointee shall give an undertaking in the shape of an affidavit to the effect that in case any adverse report about his Character any Antecedents is received from the Additional Director General of Police, (CID) JK, to whom a reference shall be made by the Principal, Government Medical College, Jammu , he shall have no right to claim his appointment, as such, and his appointment shall be deemed to have been cancelled ab-initio.

2) Verification / genuineness of the qualification certificates & Reserved Category Certificate from the concerned issuing authorities .

Whereas, - YSOU submitted a joining letter through receipt section of the office of the undersigned on 10-03-2021 without following laid down conditions of Govt. order No. 130-JK (HME) of 2021 dated 22-02-2021.


Whereas, this office was processing the show cause notice for failure to submit the requisite documents required for acceptance of joining as per Govt. order No. 130-JK (HME) of 2021 dated 22-02-2021 and non joining of duties, in the meanwhile you submitted a COVID Positive report seeking few weeks time for proper joining . As per SOP, a 21 day, additional time was granted to you on humanitarian grounds.

Whereas, you submitted an e-mail (without any supporting documents to validate your claim on 09-04-2021) stating that you are slowly recovering from COVID-19 and with the request to avail two more weeks time for joining along with all relevant documents, but you did not join physically till date.

Whereas, since as per the conditions of your appointment, your joining can only be accepted after your production of all the relevant documents / certificates in original as per appointment letter.

Whereas, you have not fulfilled all the laid terms and conditions of the appointment order, as per Govt. order No. 130-JK (HME) of 2021 dated 22-02-2021. So, joining is not accepted.

Henceforth, your request for extension of joining time cannot be considered, it is not tenable, therefore you are directed to resume your duties within 7 days positively from the date of issue of this notice failing which action as warranted under Article 128 of J&k CSR shall be initiated against you.
